Public transport will include:  
Buses, trains, boats and ferries  
and aeroplanes.

While on holidays people will naturally be out of their normal environments and therefore wish to access the community more or use communal facilities for eating and socialising. These potential contacts have the risk of the virus being transmitted.

Anyone who is showing symptoms of Covid-19 or has a confirmed positive test. Must isolate for the 14 days in line with the government guidance.

Anyone returning from a holiday overseas that is not on the high-risk list will be advised to work from home for the first 7 days to assess if they are showing any symptoms. They will also need to attend for a test between day 4 and day 6 before returning to work. If they receive a positive test they will need to isolate for the recommended duration and be tested as clear before returning to work locations.

Service users will be requested to remain away from their supported living place for 7 days if this is possible but must be tested and receive a negative test before returning to the houses.

Staff or Service Users returning from UK holidays will attend a test before returning to their home or work.

In a situation where an individual cannot stay with family while they are awaiting to be tested and they live with others. A specific risk assessment needs to be developed and the use of other P4A properties or hotels will need to be explored.

No service user who has received a positive Covid-19 test as a carrier of the virus is allowed to move back into the houses if they share under any circumstance. The manager will contact the Local Authorities Covid-19 Hub or public health England for advice on addition control measures and a plan to support will be agreed.

In exceptional circumstance staff members returning from locations that are identified as high risk. And via the keyworkers approved list may be authorised to return to work before the quarantine period but this must be agreed with the directors and only in exceptional circumstances and following a negative test between day 4 and 6 day 6. Under no circumstances should anyone who has been oversea return before a negative test. And they must not enter a house of location with individual identified as high risk for 14 days after they have returned and have received a negative test to show they are not carrying Covid-19

This has the potential for staff and service users to be a carrier and not be aware.</p> <p>Because we support individuals who are seen as high risk due to pre-existing health conditions. We must ensure they are protected when people are returning from holidays.</p> <p>Staff members who also have high risk pre-existing health conditions will also be at risk of staff or service users carrying the virus if they contract.</p> | 2                                 | 2                         | 4                           | <p>All staff have access to a test at any time due to working within health and social care. This is due to people being Asymptomatic and testing negative after a possible transmission. Then 3 days later upon being retested they have shown a positive test as are now a carrier of Covid-19 while they are still showing no signs or symptoms.</p> |
